RE: Freedom of Information Act (FOIA) Request, 5 U.S.C. 552

Dear Mr. Brooks:

This responds to your FOIA request dated February 12, 2010, in which you narrowed your November 2, 2009 request for the following:

- All records listing Death Incident ("DI") investigations and the subject of these investigations, which NHTSA has conducted pursuant to 49 U.S.C. § 30166. This includes both submissions by the manufacturers and/or NHTSA-generated documents in paper or electronic form. See the attached letter for an example of a DI investigation.
- 2) All records describing, and/or listing, any other type of investigation arising out of EWR quarterly reporting by manufacturers, excluding PE's and EA's.

In your FOIA request dated February 12, 2010, you narrowed your request for the above to:

[O]nly the listing or indices of Death Incident or Death Inquiry actions, as well as a list of other investigations arising out of EWR quarterly reporting. This would eliminate the great bulk of the records arising out of our request (manufacturer and NHTSA-generated documents).

To clarify your February 12 request, Christina Morgan, our Chief of the Early Warning Division, spoke with you by telephone on April 1, 2010.

On April 14, 2010, in our telephone conversation on your November 2, 2009 request, as narrowed by your February 12, 2010 request, you agreed to pay \$164.00 for responsive records. The enclosed CD-ROM contains copies of these responsive records.

Pursuant to the provisions of 49 CFR Part 7, this fee is based on a total of two hours of search time (which excludes two hours of search time that CAS is entitled to at no charge), at \$82.00 per hour for a search conducted at the GS-15 level.
