**Dear Secretary LaHood:** 

This past Wednesday, Chesapeake, Virginia school bus # 644 ran off a shoulder less road, dropped into a ditch and rolled over onto its left side.

According to the *Hampton RoadsPilot/Online.com*, passenger and eighth grader Chuma Awannce described what happened next:

Chuma said he was sitting on the right side of the bus toward the front, paging through a girl's yearbook, when he felt the bus swerve.

"Next, we're sitting up like this," he said, holding his right hand higher than his left. "And next I hear the bus driver say, 'Oh, shoot!' "

Then, suddenly, Chuma was airborne.

His head bumped the roof and he found himself atop a pile of students. Some were screaming, he said, including a friend who was hollering for someone to get off of him.

School bus # 664 had no seat belts.

For decades the National Highway Traffic Safety Administration (NHTSA) has insisted that during school bus crashes occupants are safety "compartmentalized" between highback, well padded and anchored seats, persistently ignoring the well established fact that the seat provides no protection for children during side impact and roll over accidents.

Since school bus lap/shoulder belts are currently a production line product, when the school bus seating standard was recently revised, we urged NHTSA to require lap/shoulder belts be installed for every seating position in all newly manufactured school buses.

Disappointingly NHTSA failed again in issuing a revised rule on October 1, 2008. Their revision calls for belts, but only in the small buses (under 10,000 lbs GVW) ignoring the need for restraints in the higher capacity, much more numerous, familiar, large, yellow school buses. Since the big buses provide 98.5% of the seats per year, as an improvement in passenger protection, the Standard revision is essentially meaningless.

As a result, on March 10, The National Coalition for School Bus Safety, and 15 other major safety, medical, public interest and parents groups listed in Attachment A as well as several interested individuals petitioned NHTSA (Docket ID # NHTSA-2010-0007) strongly urging the inclusion of lap/shoulder belts on the larger vehicles (attached).

Within the past few week there have been many examples of why proper restraints on school buses are needed.

Clearly, if restraints were present they would have prevented the fatalities and mitigated injuries. Parents have the right to ask, "We always wear our set belts and insist on our children buckling up. In the school bus why isn't my child protected."

Mr. Secretary, please use your good office to urge NHTSA's acceptance of our petition and thereby move to fully protect the 25 million children who ride back and forth to school every school day.
